**DONATION AGREEMENT**

- b. That the Donee agrees to pay all shipping charges.
- c. That the Donee agrees not to resell the Books.
- d. That this Donation Agreement shall not be binding upon the parties hereto unless dated and signed below by Donor and Donee.
- e. That the Donor makes no express warranties or implied warranties of merchantability or fitness for a particular purpose as to the Books.
- f. That Donee shall not infringe upon any United States or foreign patent, trademark or copyright applicable to the Books.

3. Delivery – Delivery date is requested to be on or before \_\_\_\_\_. Delivery shall not be deemed to be complete until the Books have been actually received and accepted by the Donee. The Donor shall bear the risk of loss of the Books until received and accepted by the Donee.

4. Force Majeure - Donor shall have no liability to Donee and Donor shall have the right to suspend shipment hereunder in the event of war, riot, flood, acts of God, fire, court order, strike, work stoppage, act of governmental authority or other causes beyond Donor’s control.
